Rising to the Challenge of Meeting Hawaii's Health Care Needs

"I do not think of reward, I am working for God and do so cheerfully."

The health care needs in our community are great, and at times, can seem overwhelming and insurmountable. We may not be able to come up with solutions overnight, but in keeping with the words of Mother Marianne, we can make a positive difference by doing everything cheerfully. The love of Christ impels us to move forward while we hold steadfast to the values that have been the hallmark of St. Francis Healthcare System in Hawaii: peacemaking, simplicity, charity, and joy.

Historic Turning Point

The year 2007 began on a high note, and that positive momentum reverberated throughout the system during the year. The transfer of St. Francis Medical Center and St. Francis Medical Center-West to Hawaii Medical Center, LLC was realized on January 13, 2007, nearly two years after plans for the divestiture was first announced. Following the sale, St. Francis Healthcare System focused on pre- and post-acute care services, particularly for the needs of Hawaii's senior population.

A memorable conglomeration was held in March at Our Lady of Kea'au for employees and their families, Sisters, and board members to celebrate this important turning point in our history and the birth of the new St. Francis Healthcare System. The daylong celebration of fellowship and fun included a Mass, transition ritual, multi-cultural entertainment, games, and delicious food.

Despite being a much leaner organization with some 200 employees, in 2007 St. Francis was able to deliver its re-defined core businesses and at the same time expand services and launch new programs.

To effectively manage the transition process, St. Francis Healthcare System commissioned a comprehensive marketing brand study to ensure the community understood that the operations of St. Francis' entities and programs were continuing. The rebranding process, which is continuing into 2008, is aimed at bringing out the enduring characteristics of strength, innovation, ethical leadership and advocacy as well as warmth, caring and compassion. The development of a new System logo, print and radio ads, printed materials, and the website all reflect the new St. Francis, communicating the relevance of our individual programs and the role of St. Francis in Hawaii's overall health care continuum.

Caring for Our Kupuna

St. Francis Residential Care Community

The needs of Hawaii's fast-growing aging population continue to weigh on our hearts. In 2007, St. Francis reached an important milestone to meet the needs of this important group. In a collaborative effort, Stanford Carr Development, LLC will serve as the development consultant for Franciscan Vistas Ewa, St. Francis Residential Care Community's master planned senior community in Ewa Villages. The proposed model community, targeted for completion in 2010, will offer affordable, accessible housing and supportive care services in one location.

Concurrently, St. Francis is moving forward with a program called "Stay Healthy at Home," a new initiative that will serve as a one-stop resource for information and refer-

als. St. Francis has already begun to offer this concierge for services to seniors at existing affordable housing developments, beginning with the state's "Honuakaha" complex in Kakaako.

St. Francis received a two-year state contract to provide medical management services to adults age 60 and older as part of the Stay Healthy at Home program. Jacob Silva, previously with St. Francis Home Care Services, oversees Stay Healthy at Home as program director. It is important to note that this new program is in line with the Joint Legislative Committee on Family Caregiving's findings for centralized accessibility to supportive care. State Senator Les Ihara, Representative John Mizuno and Hawaii's health care leaders who specialize in the care of the elderly, participated in St. Francis Healthcare System's strategic planning retreat to further refine the Stay Healthy at Home concept.

In addition, enrollment at the Franciscan Adult Day Center in Manoa increased to a daily average of 30 participants. The adult day center now has a new program director, Theresa Basta, to continue this positive momentum.

Providing the Basics

St. Francis Health Services for Senior Citizens

St. Francis Health Services for Senior Citizens celebrated 25 years of providing bathing services to frail elderly in 2007. St. Francis was awarded a \$1.785 million contract from the City and County of Honolulu's Elderly Affairs Division of the Department of Community Services, to continue Kupuna Care Personal Care Services to frail elderly for another two years. St. Francis Health Services for Senior Citizens gave 27,475 baths and met its annual quota of serving 490 clients.

Lifeline, a personal emergency response system for seniors and disabled individuals, is part of St. Francis Health Services for Senior Citizens, and increased its client base by 50 percent as a result of more referrals from community presentations.

Bringing Care into the Homes

St. Francis Home Care Services

St. Francis Home Care Services received the "Gold Seal of Approval" from The Joint Commission for demonstrating compliance with rigorous national standards for health care quality and safety. The accreditation

recognized Home Care's excellence in clinical care and is good for three additional years. Last year, the Home Care staff on Oahu and Kauai had 1,549 admissions and made 24,627 home visits.

A Renewed Commitment to End-of-Life Care

St. Francis Hospice

St. Francis Hospice, the only hospice program in the state that is accredited by The Joint Commission, provides hospice care in people's own homes as well as two facilities – The Sister Maureen Keleher Center in Nuuanu and the Maurice J. Sullivan Family Hospice Center in Ewa. The center in Nuuanu opened in 1988, and the center in West Oahu opened in 1997.

In 2007, St. Francis Hospice served 1,141 patients and the number of patient days of hospice care provided in a home setting increased 12 percent over the previous year, from 34,610 patient days to 38,908 days. We anticipate that demand will continue to grow, and St. Francis will be investing in renovations to maintain the two inpatient facilities to prepare for the future.

St. Francis is also known for looking after the psychosocial needs of family members who have loved ones receiving hospice care. St. Francis Hospice continued its series of cultural workshops by highlighting the "Korean Perspective on Death and Dying." St. Francis Hospice also observed National Hospice Month in November with its annual interdenominational memorial service followed by its annual "Light Up a Memory" events at the two hospice centers in December.

The hard work and dedication of the St. Francis Hospice staff has not gone unnoticed. In July, Sister Miriam Dionise Cabacungan, OSF received the Professional with Heart Award from the Healthcare Association of

Hawaii (HAH), part of HAH's Home Care and Hospice Caring Awards. And this past fall, St. Francis Hospice's Bereavement Program received a Family Caregiving Award in the "Support" category from KHON's Elderhood Project and the Hawaii Family Caregiver Coalition.

Earlier in the year, Felicia Marquez-Wong, bereavement coordinator, was among those who received a Mother Marianne Award for exemplifying the System's mission and living out the core values of charity, peacemaking, simplicity, and joy. The awards, started in 1999, were especially poignant this past year for two reasons. It was Blessed Marianne's first official Feast Day, the first time it was recognized by the Church, and it was also the last time St. Francis recognized outstanding employees from St. Francis Medical Center and St. Francis Medical Center-West.

Health Education to Prevent Chronic Disease

Parish Nurse/Community Outreach

Parishes continued to play a critical link to reach people with life-changing health information in 2007. In collaboration with a number of parishes, the St. Francis Parish Nurse/Community Outreach program provided monthly health notes to more than 10,000 people. In addition, the parish nurses provided breast cancer awareness sessions to more than 1,350 at Holy Family/St. Philomena parishes, nutrition education to nearly 600 students in grades 3 to 6, and diabetes education to more than 300 young students. In partnership with the Blood Bank of Hawaii, the Parish Nurse/Community Outreach program also provided a faith-based workshop on blood donations, and in 2007 held two blood drives to serve 150 patients in Hawaii.

Community Partnerships That Are Making a Difference

Mobile Care Health Project: Dental Care for the Underserved

The Mobile Care Health Project on the Island of Hawaii is a joint program of St. Francis Community Health Services and the Office for Social Ministry of the Roman Catholic Diocese. It is a shining example of what can happen when people with a shared mission work together:

The Mobile Care Health Project was supported by visiting dentists from the University of Iowa and Columbia University. Through

the Healthy Children, Healthy Smiles Keiki Dental Project, the dentists provided dental services to some 175 underserved children. In May, Mobile Care and the Hamakua Health Center partnered with Waimea schools and the University of Iowa School of Dentistry to provide comprehensive dental services to 97 children. Volunteer dental pediatric residents under the supervision of Dr. Richard Burke received Community Service Licenses and traveled to Hawaii as volunteers to bring needed dental care to underserved children ages 2 through 13.

In June, Pediatric Dentist Dr. Shantanu Lal of Columbia University School of Dentistry contracted with Mobile Care to continue specialized care for 72 children in clinics in Honokaa and Kailua-Kona. Dr. Lal presented "Oral Health and the Physician" to the Medical Staff at Hamakua Health Center and to the West Hawaii Peri-Natal Consortium.

In August, at the Statewide Pu'ukohola Heiau Cultural Festival in Kawaihae, Mobile Care partnered with Papa Ola Lokahi, North Hawaii Community Hospital - Heart/Brain Center and Hamakua Health Center to provide 62 Hawaiian men and women with oral health assessments and education that linked the importance of oral health in the prevention, control and treatment of diabetes, hypertension and heart disease.

Reaching Out to the Homeless in Waianae

Our Lady of Kea'au

Our Lady of Kea'au observed its first full year of serving the homeless who live at Kea'au Beach Park. In 2007, Our Lady of Kea'au volunteers prepared and delivered more than 6,900 meals and also clothing to the homeless who make the beach and surrounding bushes

their home. The St. Francis ministry also hosted more than 30 different religious or other non-profit organizations for retreats, conferences and celebrations with at least three groups each month.

Sister Beatrice Tom, OSF, Chief Administrator of Our Lady of Kea'au, was recognized for her efforts. She received a Distinguished Service Award from the Healthcare Association of Hawaii for her "sustained exemplary service to the health care industry and the citizens of Hawaii" during her tenure as chief executive officer of St. Francis Healthcare System of Hawaii.

Providing Resources for Our Programs St. Francis Healthcare Foundation of Hawaii

Eugene N. Tiwanak retired in January as president of St. Francis Healthcare Foundation after 30 years of dedicated service. He was instrumental in helping the Sisters of St. Francis realize many projects over the years. Sister William Marie Eleniki, OSF, a longtime educator who has been associated with our healthcare system since the 1990s, succeeds him in this key role. The Foundation team works tirelessly to raise funds to keep our programs in operation. One of the major fund raising activities was its annual Golf Healthy Challenge. Held at Kapolei Golf Course, the golf tournament enlisted the support from two major sponsors, Bank of Hawaii and McCorriston Miller Mukai MacKinnon LLP. Continuing a long tradition of success over the past 25 years, the popular annual event netted more than \$57,000 for the Sisters of St. Francis' ministries in Hawaii. In addition, the Foundation presented wealth preservation seminars twice a year as a community service, to provide the public with valuable information on financial planning.

Exploring Complex Issues Behind Health Care

International Ethics Center

The St. Francis International Center for Healthcare Ethics continues to bring difficult issues to the table for open discussion. In 2007, 18 individuals from Hawaii, California and Singapore were trained to become ethics consultants following an intensive five-day course presented by the Ethics Center. The program reviews basic principles for understanding bioethical issues and provides experience in writing ethics consultations through the use of simulated patients and families.
